SCHOLARSHIP APPLICATION GUIDELINES

Applicants/Candidates applying for the Conetoe High School Alumni Association, Inc. Scholarship MUST:

1. Be referred by an active member of the Conetoe High School Alumni Association, Inc. (*Active* includes 3 years or more of one of the following: attending any reunion event, contributing to scholarship fund, or serving on committees)
2. Be a high school senior who is eligible for graduation during the year he or she applies.
3. Applicants must have been accepted for enrollment at the school, college, or university and meet the criteria of the Conetoe High School Alumni Scholarship Award Program.
4. Show evidence that the applicant has been accepted to an accredited institution of higher learning (Community College- Technical College-Junior College- Four Year College/University).
5. Show evidence of actively participating in civic or community service.
6. Mail completed application to the Scholarship Committee so that it is postmarked by midnight April 25th deadline.

REQUIREMENTS TO MAKE A REFERRAL FOR THE ANNUAL SCHOLARSHIP

Any **active*** member of the Conetoe High School Alumni Association, Inc. for the past three (3) consecutive years or more, who would like to recommend a graduating senior who is a family member or a non-family member for the annual scholarship, may do so by completing the CHSAA member referral form and having their candidate submit both referral and scholarship application. Both will be reviewed for consideration by the scholarship committee. The referral sheet must accompany the application.

***Active** means you must be a member in good standing having shown support for the alumni association for the past 3 consecutive years or more by one or more of the following actions: attended or assisted with any of the reunion weekend activities; purchased an ad for the bi-annual souvenir book; donated \$25 or more to the scholarship fund over the past 3 years; served on committees, helped with one of the community outreach projects (adopt-a-highway, activities related to Conetoe High School Road); assisted, attended or supported the bi-annual reunion or other programs sponsored by CHSAA over the past 3 years. A member is anyone who began their education at one of the following **feeder schools**; Lawrence, White's Chapel, Coakley, Acorn Hill, Chinquapin, Mayo, First Roberson Elementary and/or Second Roberson Elementary Schools, Conetoe High School (CHS) 1948-1971. After CHS closed Students of Classes 1972-1976, K- 1982 soared into other educational institutions to complete their high school education, North Edgecombe, South Edgecombe, Tarboro High School, North Pitt, or other educational institutions.
